- O.2 That the registered office of the Trust shall be situated at Patel Nagar Nala Road, Biharsharif, Nalanda, 803101 India, or at such other places as the Board of Turstees may decide from time to time Branch/ administrative offices can be opens in any part of he country for the smooth functioning of Trust. - 0.3 The Board of Trustees shall contribute time to time for porpesr maintenance of Trust and fulfil the objective of the

- 2.7 To acquire, purchase or otherwise or undertake on loan or lease or hire temprolity and permanently and movable property necessary or convenient for the furtherance of the objects of the trust.
- 2.8 To organize and take up health, Educational, vocational training and welfare programmed for needy and poor woman and children.
- 2.9 TO support the family and relatives of artists for promoting the budding artists in the trust.
- 3.0 TO establish and award for the deserving people in the field of music Art grass root level social service, communal harmony, brotherhood and peace.
- 3.1 To encourage the emerging artists and their talents So that they can get proper recognition within and beyond the country.
- 3.2 To organize awareness camps and exhibition.
- 3.3 TO aware people about their democratic and fundamental rights.
- 3.4 To promote cottage industries, khadi and traditional handicraft.
- 3.5 To prevent any epidemics and to advocate both permanent and temprory measures fo Family Planning.

- 4.3 To make up efforts for the education, welfare and development of women, children and backward community in both urban and rural areas throughout the country.
- 4.4 To run and open the schools for the welfare and uplift of the needy children and also run adult education programmes.
- 4.5 To open/run/manage institute/ college of higher / professional/ vocational education in any part of the country for providing quality education and training to youth and children.
- 4.6 To Promote and project natural herbs and plants by cultivation preservation, Storage, processing, demonstration, creating botanical garden and providing necessary training.
- 4.7 To promote traditional therapies like yoga, naturopathy, meditation acupressure, acupuncture, massage therapy Ayurveda, homeopathy etc.
- 4.8 To establish build or manage hostels, Short stay homes rehabilition centers shelters child care center or children's Home Counseling Centers and Help line centres for women, Children and old aged persons. Durg addicts and needy persoan.
- 4.9 To promote traditional games along with the contemporary sports among youth and others.
- 5.0 To celebrate annual day of the Trust evary year as culture and social event.
- 5.1 To Promote and support voluntary donation of Blood, Eyes & other organs of Human Boday for the charitable pupose.

5.2 To take up initiate or assist social development activities or welfare programmed for bringing positive changein the lives of the common people.

5.3 To spread the teaching & Thouhts of great leaders philosophers thinkers reformers and saints

All the incomes, Movable & immovable properties of the Trust shall be solely utilized & applied towards the promotion of its aims & objectives and no profite there of shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any other manner whatsoever to the present or past members of the trust or to any person claiming through any one or more of he present or the past members.

No member of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever by virtue of this membership.

 AND GENERALLY to do in all public, charitable pursposes for public benefit without caste, Creed, Colour, Gender, Religion, Faith, Race or Nationality.

07 THE BOARD OF TRUSTEES SHALL HAVE FOLLOWING POWERS:-

- 7.1 To manage the properties, assets and funds fo the trust from time to time, such regulations (not inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection the execution of any of the subject herein contained or powers hereby vested in them and may rescind or alter any such regulation.
- 7.2 To accept donation, contributions, grants, subscription in cash or in kind from any person, company firm, association organizations, government non government or semi government agencies, nation or foreign (Money from out side India should be taken According to law of India Govt.) funding agencies, family Trust or corporate bodies for furtherance and achievement of the objectives of the trust.
- 7.3 To appoint a managing Trustee, when necessary.
- 7.4 To review the affairs of the trust and a necessary.

7.5 To appoint officers and members of staff for the trust and to prescribe their condition of service.

7.6 To open and to provide for operating accounts.

7.7 To raise loans with or without security or to invite donation and financial help.

7.8 To receive the honorarium or salary against his/her services or involvement in any of the project or programmed run by the trust, this must be decided by board of Trustees and approved by the Chairman/Chairperson.

7.9 TO authorize person(s) to sigh or execute documents on behalf of the trust.

7.10 To grant receipts for aid or donation received.

7.11 To grant special power of Attorney to represent the trustees in connection with any legal or other proceedings.

7.12 To acquire land or building on the lease or by way of purchase.

7.13 To compromise, compound or refer to Arbitration all action, proceeding and disputes relating to Trust property or properties.

7.14 To sell or give on rent/ lease or on hire any immovable or moveable property of the trust for some certain period(s) on such terms and conditions as Trustees may think fit and proper from time to time.

7.15 To open any time to bank accounts whether saving account, current account in the name of the trust or institutions or programmed run by the trust with any scheduled banks or post office and operated by the authorized signatory or signatories as board of Trustees shall think fit and proper authorize any person of persons, unless and until determined otherwise the such bank accounts shall be opened and operated jointly with signatures any two members of Board of trustees. The financial year for the Trust shall be from 1st April to 31st March and the accounts of Trust of institution or programmed run by the trust shall be audited yearly by th auditors, if paid shall be a part of outgoing amounts from the Trust funds.

7.16 To give guarantee of the assests and property of the trust, including the bank guarantee on be half of th Turst to carport bodies, persons, firms, instructions, as Trustees may decide from time to time. The truseees may not be personally liable for such guarantees or the securities.

7.21 After defraying all necessary expenses incurred in the collection or realization of the income from the trust ten percent of the balance of the income shall be kept in preserve funds to be utilized when, in the opinion of the board of trustees, there is any emergency and the remaining income may be utilized for the purpose of the Trust.

7.22 The trustees shall invest the Trust fund only for chantable purpose and welfare of the society.

7.23 It has further been decided that as and when the Trust is enclosed or dissolves all the funds of the Trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.

7.24 All questions relating to the management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or , if necessary and expedient, by circulation, every such question shall be decided by a majority of the trustees present and voting in any meeting of board of trustees or by the

circulation, as the case may be and any action or decision of such majority shall be valid as if it was done or made by the all trustees. The chairman/ chairperson shall have a casting vote.

7.25 In case of occurrence of any vacancy amongst the trustees because of death, resignation or incapacity of any trustee or any other causes a new trustees may be appointed to fill the vacancy.

7.26 All Matters not provided for in this trust deed but necessary for the administration of the trust of for giving effect ot the objectives of he trust may by resolution MADE BY THE Board of trustees carried by a special majority of two third of total number of the trustees.

7.27 If any time settler and its Trustees want to close the Trust then all the assets and liabilities of the Trust only will be transfer to the same nature of charitable that can fulfill the objective of this Trust.
